Our funding partners make a lasting impact and help The Towers transform. The Towers extends its gratitude to the Jewish Foundation of Greater New Haven, Elderly Grants Initiative, which has helped The Towers successfully complete and embark on new and transformative projects.





The Towers Foundation, with major support from the Jewish Foundation Elderly Grant Program was able to transform 13, 300 square feet of outdoor space into an accessible garden, recreational walking path and dog park. The new outdoor space has become a treasured and most utilized part of our campus. Visitors can find residents walking the wide outdoor loop for exercise every day of the week. Residents and volunteers help tend to raised planting beds and also help us harvest all the wonderful fruits, vegetables and herbs we now grow. Residents can enjoy social time with family and friends sheltered by the sun under our new shade structure. Companion pets now get to run and play and get much needed exercise in the safe and enclosed Barry's Barking Lot Dog Park, sponsored by the Vine Family. The new space elevates the quality of life for our residents, our families, staff and private duty aides and our furry friends. We could not have accomplished this project without the support of the Elderly Grants Initiative.

We thank other major funders including: Environmental Protection Agency, SWF Foundation, Goody's Hardware, Vine Family, Katherine Brown and Larry Greenberg.

A new Adult Day Program will be launching this year also, thanks to funding from the Elderly Grants Program. The Towers will launch a new in-house program to better support residents and families dealing with cognitive decline. The program will include socialization, evidence-based programs and two meals for residents along with education and respite for families.

These major programs are transformative to our campus, to our program offerings and provide a higher quality of life on our campus. We thank the Jewish Foundation of Greater New Haven for helping to shape the future.

Every year, The Towers participates in the CT Neighborhood Assistance Tax Credit Program, which helps CT non-profits pursue energy efficiency projects. The Connecticut Neighborhood Assistance Act (NAA) Tax Credit Program is designed to provide funding for municipal and tax-exempt organizations by providing a corporation business tax credit for businesses who make cash contributions to these entities. Through this important program, The Towers has been able to install energy efficient lights, purchase energy efficient washers and dryers and support the purchase of a co-generator. The savings from these programs, supported by gifts from local S-corp Companies support our meal subsidy program here at The Towers for residents in need.

The Towers extends thanks to United Illuminating, KeyBank and M&T Bank who have generously supported the purchase of tax credits to benefit these environmental projects at The Towers. Last year, M&T generously supported our new washer/dryer program with a purchase of \$30,000 credits.

In addition to its support of our capital projects, M&T employees have donated their time generously providing tech support to residents, helping with large-scale events, assisting with our Elm Dining Program and more.

M&T Bank's Regional President in Bridgeport, Frank Micallizi, explained, "M&T Bank is deeply committed to our community partners and strives to make a positive impact in peoples' lives and in the communities we serve. Cindy Leffell Lifetime Achievement Award



Cindy Leffell has been involved with The Towers for three decades, as a board member, volunteer. and family member. With a background in hospital and long-term care administration, she first joined the board after completing the Young Leadership training program at The Jewish Federation of Greater New Haven. She has also known The Towers as a family member when her mother-in-law, Freda, was a resident

During her tenure, Cindy has chaired nearly every committee including Resident Services, Facilities, Finance and Development. Thanks to her strong background in non-profit board governance, Cindy presided over significant revamping of The Towers bylaws and articles of incorporation. Cindy created lasting connections between The Towers and Yale University – especially with the Yale Urban Design Workshop and the Housing Connecticut Clinic – a joint effort among Yale's School of Management, Law School and Architecture School.

Along with Sharon Bender, she Co-Chaired the 2007 Community One event which raised a record \$500,000 for endowments for local Jewish agencies, with The Towers being a major beneficiary. She has generously volunteered her time to lead a monthly resident reminiscing group.

In 2019, Cindy and David, along with David's three brothers (Jonathan, Daniel and Michael) endowed a fund to honor the memory of their mother. During Freda Leffell's six years as a Towers' resident, "It was a wonderful home", says her daughter-in-law, Cindy. "The staff was extremely warm. They knew her well and really looked out for her."

When Freda died, the Leffells wanted to create something that would honor her memory and reflect the values that were most important in her life. They established the Freda Leffell Fund for Jewish Life at The Towers to support all that The Towers does to add to the spiritual life of its residents – the synagogue, rabbis' discussion groups, pastoral care, mashgiach, and cultural and artistic performances.

Cindy has a BA in Economics from the University of Pennsylvania and an MBA from the Kellogg School of Management at Northwestern University.



President's Service Awards



Dr. Emily Fine

Dr. Emily Fine is a gynecologist in greater New Haven who founded her gynecology practice in 1991. She has worked in the field of reproductive health for decades, advocating for women.

As a daughter of the late composer, Irving Fine, her other life long passion is music. She continues to

play the French horn in the community in the form of chamber music and with the Yale Medical Symphony. She taught for 25 years part-time at the Neighborhood Music School, who also will be partnering with The Towers. As she begins to wind down her medical career, she is working towards bringing music to the community especially for those populations who will benefit from its healing and nurturing properties. Given the compelling data supporting the importance of music in cognition and social/mental health, she has sought to create a formalized two part music program at The Towers entitled "Fine Musical Offerings". This will include a formal chamber music series with its inaugural Holiday Concert on December 7, 2025.

She and her woodwind quintet known as "The Elm City Winds" play regularly at The Towers and throughout the community, often offering their services as fundraisers for important causes.

She is married to retired surgeon, Dr. Stephen Stein.

Andrew Danzig

Andy Danzig has had a long connection to The Towers through his wife, Lorri, who taught Let it Shine programs and Tai Chi classes for many years. He jumped at the opportunity to deepen that connection by creating a welcoming outdoor space for The Towers residents. It fit right in with his passions and areas of expertise. Thanks to Andy's vision and dedication, The Towers now has a beautiful and thriving outdoor space. All of the plants, flowers and trees have been hand-picked and thoughtfully arranged with Andy's expertise in landscape architecture.

Andy has been an environmental advocate since he participated in the first Earth Day (1970) as a Boy Scout in Syracuse, NY. Later, he focused on Ecology while earning a BS in Biology from UConn. After graduation, he spent two years in Niger, West Africa as a Peace Corps volunteer working on a fisheries project. His introduction to plants and landscaping began while working for landscape architects in West Virginia and

Connecticut. Andy went on to earn a Master's degree in Environmental Engineering from Virginia Tech. His enthusiasm for plants and gardening continued, even while working as a Professional Environmental Engineer for 25 years at the Tennessee Valley Authority, as a technical expert for an environmental NGO in Israel, and for environmental consulting firms in Connecticut.

After retiring from engineering, Andy formalized his love of plants by completing the UConn Extension Master Gardener Program. As an Advanced Master Gardener he enjoys enhancing people's connections to landscapes, emphasizing the use of native plants. Andy also serves on the board of the Greater New Haven Green Fund and is the Trail Master for the Town of Woodbridge.



In Memoriam: A Lifetime of Leadership and a Legacy of Giving David E. Schancupp • May 11, 1941 - August 25, 2025



David Schancupp made a lasting impact on The Towers, volunteering his time and leadership skills. He served on our Board of Directors and as Board Chair. He was intrumental in bringing theater and music to The Towers and in bringing our residents to cultural events across Greater New Haven, David generously left The Towers a percentage of his estate which will help support the arts right here on our campus and our bus fund

to bring residents to shows and performances. Thanks to David's legacy, the impactful programs he initiated will continue to thrive in perpetuity. His presence and influence will stay with us through his legacy gift.

David was an accomplished and respected trial attorney for over fifty years as well as a longtime, enthusiastic member of the New Haven County Bar Association and the Connecticut Bar Association. He became known as the dean of the landlord-tenant bar in New Haven County, often assisting other attorneys with their cases and always dispensing advice freely and generously.

But David was much more than an outstanding attorney. He was truly a Renaissance man, a gifted actor and singer who appeared in countless musical productions around the state. While he had a particular fondness for Gilbert and Sullivan, he took great pride in his role as Tevye in two productions of Fiddler on the Roof, the most recent with the First Church Theatre Group in Guilford in 2015.

He was a lifelong, loyal fan of the New York Giants and a member of the Walter Camp Football Foundation. For more than twenty-five years, David served as 50% of the "chain gang", moving the chains from the sidelines at every Yale football game.

David earned his undergraduate degree at the University of Connecticut and his law degree at Columbia University. He then joined the judge advocate corps of the United States Air Force, serving for many years, retiring with the rank of Lieutenant Colonel.


